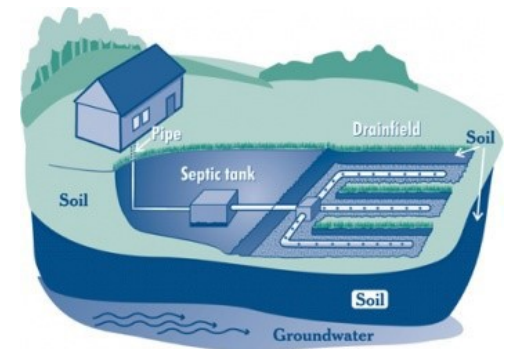

A POWTS is designed to provide a long term solution for onsite wastewater treatment. A system is designed, approved and installed to meet the requirements of the Wisconsin Plumbing Code and Clark County Ordinance.

The system does require periodic maintenance to function properly. Section SPS 383.52 (1) Wisconsin Administrative Code states that the owner is responsible for the operation and maintenance of the POWTS.

Section 20-201, Clark County Code of Ordinances, and SPS 383.54, Wisconsin Administrative Code specify management operations required for all POWTS. There are three types of POWTS requiring three different types of maintenance:

- A holding tank
- A POWTS using a septic tank and soil infiltration component
- A POWTS with treatment component requiring maintenance on a shorter interval.
