### 1. Agreement:

a. Lessee is subject to and shall fully comply with the following Facility specific policies and standards as well as the Standard Facility Rental Policies within the Forestry and Parks Department.

### 2. Facility Rental Length:

a. Full Day = 6:00 AM to 12:00 AM (midnight)

### 3. Facility Rental Seasons:

- a. Winter = November 1<sup>st</sup> to March 31<sup>st</sup> (No heated/indoor rentals)
- b. Summer = April  $1^{st}$  to October  $31^{st}$

### 4. Facility Renter Status:

- a. Private Party (PP)
  - i. An event that is not open to the general public with no exchanging of funds occurring (i.e. parties, weddings, picnics, etc.).
- b. For Profit Event (FP)
  - i. An event which involves a monetary exchange for goods or services rendered, having a desired end result being financial gains for the renter (i.e. auctions, fundraisers, sales, etc.).
- c. Non-Profit Organization (NPO)
  - i. Proof of designation by IRS as having a 501(c)3 status is required.

#### 5. Facility Rental Rates:

  - i. PP = \$300 per day

    - 1. Choice of buildings.
    - 2. Option to contract catering services with Forestry and Parks Department current catering leaseholder.
- n. Storage (Winter = 1st Saturday in November to 1st Saturday in April) (Summer = 1st Saturday in April to July 15th)
  - i. All Items under 20 ft = \$150.00
  - ii. All Items 20ft to 30ft = \$200.00
  - iii. All Items over 30ft = \$250.00
- o. Camping (Campsites are available on a first-come basis via self-registration only).
  - i. Electric = \$26.00 per unit per night.
  - ii. NON-Electric = \$20.00 per unit per night.
  - iii. Off Season Camping Rates October 1st-April 30th (limited amenities available).
    - a. Electric = \$12.00 per unit per night.
    - b. NON-Electric = \$7.00 per unit per night.
  - iv. Septic Dump = \$10.00
- p. Non-Refundable Reservation Fee = \$10.00
- 6. Security Deposit:
  - a. Security Deposits shall be in the amount of 20% of the total rental fees with a minimum of \$100.00.
    - i. Security Deposit may be waived if the event is not open to the general public.
- 7. **Payment**:
  - a. Full payment of appropriate security deposit amount is required at the time of rental confirmation.
    - i. If security deposit is waived, rental fees must be paid in full at time of rental confirmation.
  - b. All remaining rental fees must be paid in full before 30 days prior to rental start date.
- 8. Maximum capacity: Facility Specific Limits May Apply.
- 9. **Set up and Take Down:** Lessee is granted the day prior to reservation start date for set up and one day after reservation end date for take down. Any additional time will be charged as an additional rental day.

- a. Grounds usage subject to additional rental.
- b. No ATVs or UTVs are allowed at the Facility or surrounding grounds unless prior written authorization by Lessor is provided. Motor vehicles shall remain on gravel and/or blacktop driveway/parking lot as buried electrical, phone, water and sewer lines are located throughout the grounds
- c. All campground users are expected to pay the required campground fees. With this facility rental you are not entitled to free use of the campground. This facility rental also does not grant you exclusive access to these areas, as well as the restrooms, and other members of the public may utilize them during your rental time.
- d. Manure must be removed from barns and grounds and deposited in the manure bunker located in the NE corner of the Fairgrounds. Any cleanup completed by Forestry and Parks will be invoiced to Lessee at a rate of \$50/hr/employee.
- e. Any animal bedding used for housing and/or showing animals must be supplied and removed by the Lessee.
- f. Any shod animals being housed or shown in the Multi-Purpose Livestock Building (Map Site 33) will have a minimum 6" of bedding material between the floor and the shod hoof of the animal.
